### 'Don't Ask': White House Appeals Return of Nurse

The Obama administration opened another legal front Tuesday in defense of "don't ask, don't tell," appealing a federal judge's decision to reinstate a decorated Air Force nurse who was discharged after being outed as a lesbian.

The Justice Department told the Ninth U.S. Circuit Court of Appeals in San Francisco that it would appeal a ruling issued two months ago in favor of Maj. Margaret Witt, the first service member to successfully challenge her dismissal under the 1993 law.

The law prohibits openly gay or lesbian troops from serving in the armed forces. In a separate case, a federal judge in Riverside ruled the law unconstitutional in September, saying it intrudes on service members' private lives and harms the military

by removing skilled personnel and increasing troop shortages.

President Obama opposes the law and has asked Congress to repeal it, but is defending it in court.

Witt joined the Air Force in 1989. She was a reserve flight nurse at a base in Washington state in 2004 when a local man reported that Witt had a sexual relationship with his wife. She was discharged in 2006.

The appeals court allowed her to seek reinstatement in

a 2008 ruling that required the military, for the first time, to show that discharging a particular gay or lesbian service member would promote important goals, such as troop readiness. Previous rulings had accepted the government's argument that "don't ask, don't tell" helped the armed forces overall.

In a trial based on that ruling, government lawyers argued that Witt was legitimately discharged for an adulterous relationship. U.S. District Judge Ronald Leighton rejected that explanation and said the evidence showed that Witt's unit was disrupted by the removal of an esteemed officer.

Witt's lawyers said Tuesday she will return to duty while the government appeals. In a statement, she said, "I am thrilled to be able to serve in the Air Force again."





### Ohlone Nation Honors Veterans with Ceremony & Awards

On 7 NOV 10, after the Veteran's Day Parade, the Post was requested to join the Ohlone Tribe for a ceremony at the Memorial Grove, the grassy area between the Opera House and the Veterans Building. This year, Chief Tony Cerda presented the Congress of American Indians' "Warriors Medal of Valor" to the American Legion Posts in San Francisco from the Ohlone Nation.

A wreath in the shape of that medal will be placed on the



octagon and a ceremony of dance, songs and prayers will bring us together. The Veterans and the Ohlone are returning

home to a sacred site.

San Francisco is an Ohlone place of origin and the Memorial Grove is the site where soil from the Battlefields of World Wars I, II and Vietnam are buried. This is the first year of a four-year ceremony to celebrate their homecoming.

The Tribe presented our Post with the Valor Medal for conspicuous performance of duty, patriotism and pride in the finest traditions of the Armed Forces of the United States.

*On behalf of the San Francisco Posts of the American Legion, we object to, and request that you rescind, your resolutions agreeing in principle to enter into memoranda of understanding by which you would lease space in the Veterans' Building to the Arts Commission and the Opera on an indefinite or long-term basis or permanently. The effect of any such lease would be the permanent withdrawal of any such leased space from use for the patriotic purposes for which the building was erected.*

So begins a letter delivered to the Trustees by the American Legion War Memorial Commission.

*It is our opinion that your proposed leases to the Arts Commission and the Opera are not consistent with, and are in violation of, your duties as successor trustees under the Trust Agreement because the Trust Agreement requires you to assure that use of the Veterans' Building is by the San Francisco Posts and such other patriotic organizations as the San Francisco Posts may from time to time desire to install.*

The 9 page letter requests the Trustees reconsider their ill-conceived plans. Further information will be forthcoming when a response by the Trustees is made.
