### White House Opposes DADT, Marriage Provisions in Defense Bill

Today, the administration issued its Statement of Administration Policy (SAP) regarding the National Defense Authorization Act (NDAA), as passed by the House Armed Services Committee earlier this month.

Responding to a decision by the House Armed Services Committee to include provisions in the NDAA attempting to expand the "Don't Ask, Don't Tell" repeal process and to reaffirm or expand the Defense of Marriage Act, the administration stated today that it "strongly objects" to all three amendments – expanding on previous comments to Metro Weekly by White House spokesman Shin Inouye that the administration had "serious objections to any amendment that would unnecessarily delay" repeal.

Despite the strong objections, the White House did not state that inclusion of any of the three provisions would lead to a recommendation that President Barack Obama veto the bill – as the SAP states would be recommended as to other provisions relating to the F-35 Joint Strike Fighter, the New START Treaty and detainees.

From the SAP:

*Attempts to Prevent, Delay, or Undermine the Repeal of "Don't Ask, Don't Tell": On December 22, 2010, President Obama signed into law the Don't Ask, Don't Tell Repeal Act of 2010, in order to strengthen our national security, enhance military readiness, and uphold the fundamental American principles of fairness and equality that warfighters defend around the world. As required by that statute, DoD is diligently working to prepare the necessary policies and regulations and conducting educational briefings to implement the repeal. Should it be determined, as required by the statute, that the implementation is consistent with the standards of military readiness and effectiveness, unit cohesion, and military recruiting and retention, then the President, the Secretary of Defense and the Chairman of the Joint Chiefs of Staff will send forward the required certification. The Administration strongly objects to any legislative attempts (such as section 533) to directly or indirectly undermine, prevent, or delay the implementation of the repeal, as such efforts create uncertainty for servicemembers and their families.*

*Military Regulations Regarding Marriage: The Administration strongly objects to sections 534 and 535, believes that section 3 of the so-called Defense of Marriage Act (DOMA) is discriminatory, and supports DOMA's repeal.*

The DADT-related amendment, proposed by Rep. Duncan Hunter (R-Calif.), expands the required certification process for repeal – which already includes the president, defense secretary and chairman of the Joint Chiefs of Staff – to include the sign-off of the service branch chiefs of the Army, Navy, Marine Corps and Air Force.

The first of the two marriage amendments, proposed by Rep. Vicky Hartzler (R-Mo.), "reaffirms the policy of section 3 of the Defense of Marriage Act." The amendment – made applicable to the NDAA by referencing Department of Defense rules and regulations, as well as DOD employees – also repeats section 3's policy of defining "marriage" and "spouse" as relating only to opposite-sex marriages.

For those interested in obtaining a copy of their DD214, keep in mind that there are things that you can do on your own at no or low cost, but it will take you some time and effort.

For benefits, forms, or proof of VA Benefits, register with the VA at <http://www.va.gov/>.

The Adjutant also has a copy of Standard Form 180 for obtaining records. You can email the Adjutant or send me a snail request. The form can be filled out online, and if you want help, just make an appointment to meet me at the office and we can fill it out and mail/fax it from there.

If you have filed your DD214 with Post 448, we can supply as many copies as you need, free of charge. It is not a requirement, but it is recommended that you provide the Post with a copy of your DD214 and any other military records you might have. The Adjutant has embarked on a program to digitally scan and store all records, so copies of your records are just a matter of a few mouse clicks.

Finally, if you want to obtain your decorations, you can write to the Military Personnel Records Center, 9700 Page Blvd, St Louis MO 63132. I have a form you can use for this purpose. If you want a copy of the form, send your request to me at [adjutant@post448.org](mailto:adjutant@post448.org) by email or send me a request by snail mail to the Post's mail box. (BTW, in researching this information, I found out that my personal medal count went from 4 medals and 2 unit citations, to 7 medals and 2 unit citations. This can happen when medals are awarded after your service is over. For example, I found I was entitled to the Vietnam Defense Commemorative Military Medal, instituted in 1995. It was struck to honor all military personnel who served in South Vietnam or in direct support from Thailand, Guam, Okinawa or the waters off shore between 1962 and 1975.)

You can also get your mounted ribbons or medals from Medals of America at <http://www.medalsofamerica.com/>. This site is also good for researching medals as they offer a history of when a medal was first struck, the dates of inclusion, if any, and who is eligible.

These are not the only options. You can do more research by simply Googling

It is intended to be delivered to the BoT at the beginning of discussions, and is also the WMC's instructions to the negotiating committee that these are the minimum conditions that we will accept.

are now 6 months in to a very tight 24-month schedule. The Project Manager for the City has given us until July 15 to not just decide what space we need, but also to finalize our agreement with the BoT and decide on room configurations and specifications. Thus it is critical to decide now on our spaces.

**While it is normally best practice in negotiations to ask for more than you will settle for and gradually negotiate away portions until you get the best deal you can, we simply do not have time for this approach.** As we all know, the design phase for the retrofit began in January, so we

**Secondly, this demand document is for space that we can reasonably justify** that will be needed by future veterans of San Francisco. It has ample office space and meeting space on the second floor for the AL Posts and other veteran groups we choose to install, and space on the third floor for the Department of California and a variety of Veterans Ser-

vice organizations that will provide services and assistance to veterans. **This is a reasonable set of demands, one that we think we can secure without a lot of unnecessary maneuvering around the BoT.**

This version has only a few changes from the previous version sent out last Tuesday. We will propose that it be accepted by the WMC May 17\*.

ALWMC Agreement. Once the negotiating committee brings back the best deal they can get from the BoT, it will be voted on by the entire ALWMC. If that deal with the BoT is ratified by the majority of the posts of the ALWMC, **this document is a promise by each post that it will abide by the final decision.**

We will be voting on our plans attached, so be ready to speak up or **suffer the consequences.**



### Gay Troops To Hold Las Vegas Convention

A group of actively serving gay, lesbian and bisexual military personnel is planning its first convention this fall in Las Vegas in what may be another sign that the "don't ask, don't tell" policy's days are numbered.



Wednesday that found 78 percent of respondents said they were "out" to at least some in their unit. More than one in four said they had "come out" since President Barack Obama signed the bill to repeal DADT.

By scheduling its Armed Forces Leadership Summit for 13-16 OCT 11, OutServe, an underground network of more than 3,000 gay troops, appears to be thumbing its nose at the 17-year-old rule.

The findings, which may help explain the reasoning behind the high-profile summit, confirms that troops who have told colleagues they are gay have suffered "no negative impact," said

group spokesman Jonathan Hopkins, a former Army captain and veteran of combat in Iraq and Afghanistan.

The group said it hoped the summit would "provide an international forum on enhancing military readiness through encouraging an environment of respect with regard to sexual orientation and gender identity." Although it is unclear how many active-duty personnel will risk attending – DADT remains in effect as the repeal process is implemented – organizers say it will be open to veterans and civilians as well.

“military records”. Keep in mind the cost can be from zip to hundreds of dollars. There are many unscrupulous people out there more than willing to take your money, so be careful.

Whether you have three or thirty medals, all Legionnaires should wear their honors with pride, particularly on special occasions such as parades, dinners, and other outings where the Post’s image is at stake. It’s a reminder to the general public and straight Veterans that we also served.

Remember, in the military, if you failed to wear your honors properly, you were considered to be out of uniform.

You earned your honors. Wear them with pride.

Conclusion:

1. Something the Post should keep in the back of its collective mind, once the Repeal of DADT has been certified, there is a very distinct possibility that other predominantly GLBT, or at least Gay Friendly, posts will be organized across the country, particularly in the

larger cities like Boston, New York, Los Angeles, Portland, etc. Post 448 must remain in the forefront by offering assistance in their organizational efforts, as well as partnering with these new Posts to present a united front.

2. Finally, Peace Officers Memorial Day and Police Week is an observance in the United States that pays tribute to the local, state, and Federal peace officers killed in the line of duty.

The next time you run into a Police Officer or Firefighter, who is not engaged in an emergency situation, thank them for their service and remind them to stay safe. Remember, Police Officers and Firefighters are our first line of defense.

The second, offered by Rep. Todd Akin (R-Mo.), expands upon the current restrictions of DOMA by effectively banning same-sex marriages from being performed at military bases or by military employees. Akin's amendment prohibits weddings

from taking place on military installations - such as bases - or other Department of Defense property if they don't comply with DOMA. It also prohibits chaplains or other DOD employees from performing non-DOMA-complaint marriages while "acting in an official capacity."

Servicemembers Legal Defense Network executive director Aubrey Sarvis said in a statement, "We are heartened to see the White House standing firm against attempts to use the defense spending bill as a vehicle for delaying or derailing repeal and expanding DOMA. The
